WORKING DUES CALCULATIONS EFFECTIVE JUNE 1, 2017

Journeyman	Total Contractual Package X Hours Worked X 1.6% = working dues
Residential Journeyman	Total Contractual Package X Hours Worked X 0.85% = working dues
Warehouse	Total Contractual Package X Hours Worked X 0.75% = working dues
All Apprentice's, SML/T, &	Total Contractual Package X Hours Worked X 0.55% = working dues

EXAMPLE: 40 hour work week

Eau Claire Journeyman	40 X \$56.07 x 1.6% = \$35.88
Residential Journeyman	40 x \$49.18 x 0.85% = \$16.72
3rd year BT Apprentice	40 x \$42.02 x 0.55% = \$9.24
